

Lacey and the Board on the background. He said he was working on a letter to LAFCO that he will send to the District's attorney for vetting and approval.

c) DISCUSS FENCE AND MAINTENANCE ISSUES The General Manager reported that the fences on Kimberly Court and Garry Court are being repaired. Discussion followed about sending a letter to all of the homeowners telling them who was doing the fence work and that they could contact them directly. Other items for a letter to the homeowners were about lawn clippings, trash in retention ponds, trash from school kids getting off the bus, explanation about what we do and where the money goes, cutting trees and bushes, etc. There was also a suggestion that we say something about stray cats. 



HI Ethan,

I don't think you have seen the site, but there is a walking/jogging path that goes through the area where adults mostly jog along the path and up the hill, to Hillgate Rd. It is a substantial elevation difference and currently it is a slope in the terrain. There will have to be a retaining wall on that side of the 5-12 year old play structure and we are thinking we will need steps up to Hillgate. Right now,

the County has K-Rails on the edge of the road where the joggers run up to and turn left to the sidewalk along Hillgate. We want to keep that accessible but still safe. Maybe we could do something similar to what I did in another park, but not quite so massive or elaborate. (see attached) I don't think we want it in the play area, but rather beside it. Somehow we want to keep that somewhat open and it definitely will need a retaining wall, so whatever works there. Maybe a retaining wall the width of the containment and a natural jogging path (without steps) between the containment and the fence. Thanks
