

RESOLUTION __, 2019

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CORTINA COMMUNITY SERVICES DISTRICT APPROVING THE DISTRICT'S FISCAL YEAR 2019/20 FISCAL YEAR PRELIMINARY BUDGET

WHEREAS, the Cortina Community Services District (District) Board of Directors reviews and accepts a monthly treasurer's report that includes statements of cash flows, account and investment balances, and budget to actual reports; and

WHEREAS, California Government Code Section 61110 (a) states that on or before July 1 of each year or, for districts using two one-year budgets or a biennial budget, every other year, the board of directors may adopt a preliminary budget that conforms to generally accepted accounting and budgeting procedures for special districts; and

WHEREAS, the District's adopted 2018/19 budgeted revenue and expense will serve as the Preliminary Draft Budget for the 2019/20 Fiscal Year until the preparation of a draft final budget; and

WHEREAS, the Board intends to present and adopt a Final Budget for the 2019/20 Fiscal Year at its August 2019 Regular Board meeting, and has caused the preparation for publication the required Notice of Public Hearing in both newspapers of general circulation, regarding final budget adoption; and

WHEREAS, said draft Preliminary 2018/19 Budget is included herein for consideration.

NOW, THEREFORE, BE IT RESOLVED that:

SECTION 1. The Board of Directors of the District does hereby approve and adopt the 2019/20 Fiscal Year Preliminary Budget as presented.

SECTION 2. The District General Manager or his/her designee is hereby authorized to expend the funds contained within the 2019/20 Preliminary Budget in accordance with financial policies adopted by the Board.

SECTION 3. The District General Manager or his/her designee is hereby directed to publish the Notice of Public Hearing for the adoption of the 2019/20 Fiscal Year Final Budget.

SECTION 4. The District General Manager or his/her designee is directed to prepare the draft Final Budget for public distribution during the first week of August 2019 in advance of said consideration by the Board.
